For the past several months, the Corporation and the Tabangao Shell Refinery Employees Association – PTGWO (the "Union") conducted negotiations for the renewal of the Collective Bargaining Agreement. As of 25 August 2016, no agreement has been reached by the parties. On 31 August 2016, the Corporation was served a Notice of Strike filed by the Union on the basis of a bargaining deadlock. Both parties have been invited to attend a Mediation Conference before the National Conciliation & Mediation Board on 02 September 2016 to advance negotiations towards reaching an agreement.

In case no agreement is reached, the Corporation will resort to its business continuity plans and rely on government support to ensure unhindered operations to supply the needs of the country.
