Update on the Collective Bargaining Deadlock; Settlement

The Corporation and the Tabangao Shell Refinery Employees Association (the "Union") have been attending the Mediation Conference before the National Conciliation & Mediation Board (the "NCMB") to advance the negotiations of the Collective Bargaining Agreement after the Corporation was served a Notice of Strike filed by the Union on 31 August 2016 on the basis of a bargaining deadlock. On 3 October 2016, the Corporation received confirmation from the NCMB that the Union filed a strike vote report on the same day.

During the mediation conference before the NCMB on 05 October 2016, the Corporation and the Union agreed to amicably settle the labor dispute and withdraw the Notice of Strike docketed before the NCMB.
