### **Item 9 - Other Events**

Following a competitive tender process, Pilipinas Shell Petroleum Corporation ("SHLPH") secured a five-year loan amounting to PhP9 billion evenly split with the Bank of the Philippines Islands ("BPI") and Metrobank. This also renews an existing 5-year loan with BPI maturing on March 8, 2023. The loan will reduce SHLPH's exposure to short-term volatilities in the market as it benefits from the low interest rate for its cash requirements.
