Request for Extension to File its 2019 Reports

Ladies and Gentlemen:

We refer to the Securities and Exchange Commission's Memorandum Circular No. 5, Series of 2020 and Notice dated 18 March 2020 in relation to the Extension of Filing of the 2019 Annual Reports including the Applicable Quarterly Reports for Year 2020 and the 2019 Audited Financial Statements and Relaxing of the Requirements thereof, respectively, issued in view of the Enhanced Community Quarantine (ECQ) to address the spread of COVID-19.

We respectfully request for an extension of time to file the Corporation's 2019 Annual Report and Audited Financial Statements, including the Sustainability Report (the "Reports") up until 30 June 2020. Using its available resources, the Corporation will endeavor to submit the Reports prior to the extension set. While its Board of Directors has approved the Reports on 26 March 2020, the Corporation expects no significant changes from said date until date of filing. The request for extension is necessary to deal with logistics and administrative constraints to finalize the Reports considering the restricted staff movements and work-from-home arrangements.

Moreover, the Corporation was constrained to move its Annual Stockholders' Meeting ("ASM"), which the By-Laws have set to be held on the second Tuesday in May. The Corporation made the relevant disclosure in the Current Report (17-C) filed after its Board Meeting. The Board likewise delegated the authority to determine the AGM date and closing of the Stock and Transfer Book to the President and Chief Executive Officer and the Treasurer. The Corporation plans to hold its ASM in July 2020, as may be finally determined by the foregoing officers and in compliance with the notice and legal requirements provided under the applicable laws.

Finally, the Corporation commits to continuously observe its disclosure obligations under the Securities Regulation Code and the Philippine Stock Exchange Consolidated Listing and Disclosure Rules and to comply with succeeding regulatory issuances.

We trust that you will respond favorably to our request. We acknowledge the prompt support provided by the Commission and the Exchange to allow us to abide by the legal requirements in an efficient and effective manner.
